General Copyright Policy

We reserve the right to change any and all permission policies from year to year as we see fit. We take into account the intellectual content that is being sought and adapted (or reprinted) and from which components the content is taken from. Based on this information, and the type of research/project being conducted, a fee may be charged for the permission to adapt/reprint that specific content. Fees are imposed on a case by case basis, are non refundable, and also subject to change from year to year. Pro-Ed Inc. does not apply any discounts for copyright permission fees. Pro-Ed Inc. requires payment for your request prior to granting permission and releasing any materials. A confirmation letter will be sent to you upon receipt of payment. All fees are due prior to the release of any material or granting of permission and are not refundable. Should Pro-Ed Inc. in its sole discretion, determine the use of our material by you, the client, is contrary to the original intent as we understood it in your letter requesting permission, we reserve the right to demand that you cease and desist in your use of Pro-Ed Inc.'s material and remove it from the marketplace. 1. Complete title (and/or acronym), including the edition of the product (ISBN if applicable)
2. Specific intellectual content being sought (i.e. item numbers, subtest titles, tables, figures, page numbers, pictures, photographs, etc.)
3. Requester's complete contact information (including title, institution name (if applicable), address, phone, fax, and email)
